

DEALPATH END USER LICENSE AGREEMENT

PLEASE READ THIS END USER LICENSE AGREEMENT (“AGREEMENT”) CAREFULLY BEFORE DOWNLOADING, INSTALLING OR USING THE MICROSOFT OUTLOOK ADD-IN SOFTWARE PROVIDED BY DEALPATH, INC. (“DEALPATH”) OR ANY RELATED DOCUMENTATION (COLLECTIVELY, THE “SOFTWARE”).

This Agreement supplements the Dealpath Terms of Service located at <https://www.dealpath.com/tos/>, or if you (or the company or other entity that you represent) and Dealpath have entered into a separate written agreement for use of the Dealpath’s services, such separate written agreement (as applicable, the “**Dealpath Customer Agreement**”).

Dealpath is willing to license the Software to you only (a) if you are an Authorized User under the Dealpath Customer Agreement (as such term is defined in the Dealpath Customer Agreement), and (b) upon the condition that you accept all the terms contained in this Agreement. By clicking on the “I accept” button below or by downloading, installing or using the Software, you indicate that you are an Authorized User under the Dealpath Customer Agreement and have read and understand this Agreement and accept all of its terms. If you do not accept all the terms of this Agreement then Dealpath is unwilling to license the Software to you.

1. Grant of License. Subject to your compliance with the terms and conditions of this Agreement, Dealpath grants you a non-exclusive and non-transferable license for a single user to install and use the executable form of the Software on a single computer, solely in connection with your authorized use of the Dealpath’s services under the Dealpath Customer Agreement. You may make a single copy of the Software for backup purposes, provided that you reproduce on it all copyright and other proprietary notices that are on the original copy of the Software. Dealpath reserves all rights in the Software not expressly granted to you in this Agreement.

2. Restrictions. Except as expressly specified in this Agreement, you may not: (a) copy or modify the Software; (b) transfer, sublicense, lease, lend, rent or otherwise distribute the Software to any third party; (c) make the functionality of the Software available to multiple users through any means, including, without limitation, by uploading the Software to a network or file-sharing service or through any hosting, application services provider, service bureau or any other type of services; or (d) use the Software in any unlawful manner, for any unlawful purpose, or in any manner inconsistent with this Agreement or the Dealpath Customer Agreement. You acknowledge and agree that portions of the Software, including, without limitation, the source code and the specific design and structure of individual modules or programs, constitute or contain trade secrets of Dealpath and its licensors. Accordingly, you agree not to disassemble, decompile or otherwise reverse engineer the Software, in whole or in part, or permit or authorize a third party to do so, except to the extent such activities are expressly permitted by law notwithstanding this prohibition.

3. Ownership. The Software is licensed, not sold. Dealpath and its licensors own all rights, title, and interest in and to the Software, including all intellectual property rights therein. The Software is protected by United States copyright law and international treaties. You will not delete or in any manner alter the copyright, trademark, and other proprietary rights notices or markings appearing on the Software as delivered to you.

4. Term and Termination.

a. This Agreement remains effective until terminated by either party. Dealpath may terminate this Agreement with or without notice, at any time and for any reason. You may terminate it at any time by destroying all copies of the Software in your possession or control. This Agreement will automatically terminate without notice if you breach any term of this Agreement, or upon expiration or termination of the Dealpath Customer Agreement.

b. Upon any termination, you will promptly destroy all copies of the Software in your possession or control. Sections 4(b), 5, 6, 7, 9 and 10 will survive any termination of this Agreement.

5. Disclaimer of Warranty. THE SOFTWARE IS PROVIDED “AS IS”, WITHOUT WARRANTY OF ANY KIND. DEALPATH DOES NOT WARRANT THAT THE SOFTWARE WILL MEET YOUR REQUIREMENTS OR THAT THE SOFTWARE WILL BE ERROR-FREE OR UNINTERRUPTED. DEALPATH EXPRESSLY DISCLAIMS ALL WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, RELATING TO THE SOFTWARE AND ANY DATA ACCESSED THEREFROM OR TRANSMITTED THEREBY, OR THE ACCURACY, TIMELINESS, OR COMPLETENESS OF THE SOFTWARE AND ANY DATA ACCESSED THEREFROM OR TRANSMITTED THEREBY, INCLUDING ANY IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NONINFRINGEMENT, AND ANY WARRANTIES AND CONDITIONS ARISING OUT OF COURSE OF DEALING OR USAGE OF TRADE. NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED FROM DEALPATH OR ELSEWHERE WILL CREATE ANY WARRANTY OR CONDITION NOT EXPRESSLY STATED IN THIS AGREEMENT.

6. Limitation of Liability. IN NO EVENT WILL DEALPATH BE LIABLE TO YOU FOR ANY SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE OR CONSEQUENTIAL DAMAGES (INCLUDING LOSS OF USE, DATA, BUSINESS OR PROFITS) OR FOR THE COST OF PROCURING SUBSTITUTE PRODUCTS ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE USE OR PERFORMANCE OF THE SOFTWARE, WHETHER SUCH LIABILITY ARISES FROM ANY CLAIM BASED UPON CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE, AND WHETHER OR NOT DEALPATH HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE. DEALPATH’S ENTIRE LIABILITY UNDER THIS AGREEMENT FROM ALL CAUSES OF ACTION AND UNDER ALL THEORIES OF LIABILITY WILL BE LIMITED TO AND WILL NOT EXCEED ONE HUNDRED U.S. DOLLARS (\$100) OR THE TOTAL AMOUNT YOU PAID TO DEALPATH FOR USE OF THE SOFTWARE, WHICHEVER IS GREATER. THE FOREGOING LIMITATIONS WILL SURVIVE AND APPLY EVEN IF ANY LIMITED REMEDY SPECIFIED IN THIS AGREEMENT IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.

8. U.S. Government Users. The Software and Documentation are “commercial computer software” and “commercial computer software documentation,” respectively, as such terms are used in FAR 12.212 and other relevant government procurement regulations. Any use, duplication, or disclosure of the Software or its Documentation by or on behalf of the U.S. government is subject to restrictions as set forth in this Agreement.

9. Export Law. You agree to comply with all applicable federal laws, regulations and rules that prohibit or restrict the export or re-export of the Software outside the United States, and will complete all undertakings required by such laws, regulations and rules, including obtaining any necessary export license or other governmental approval.

10. General. This Agreement will be governed by and construed in accordance with the laws of the State of California, without regard to or application of conflicts of law rules or principles. The United Nations Convention on Contracts for the International Sale of Goods will not apply. Any legal action or proceeding relating to this Agreement shall be brought exclusively in the state or federal courts located in San Francisco, California. Dealpath and you hereby agree to submit to the jurisdiction of, and agree that venue is proper in, those courts in any such legal action or proceeding. You may not assign or transfer this Agreement or any rights granted hereunder, by operation of law or otherwise, without Dealpath's prior written consent, and any attempt by you to do so, without such consent, will be void and of no effect. Except as expressly set forth in this Agreement, the exercise by either party of any of its remedies under this Agreement will be without prejudice to its other remedies under this Agreement or otherwise. Any notice or other communications to be given under this Agreement will be in writing and given (a) by Dealpath via email (to the address that you provide), posting on the Dealpath website located at <https://www.dealpath.com/>, or via the user interface of the Dealpath's services; or (b) by you via email to support@dealpath.com or such addresses Dealpath may specify in writing. The date of receipt will be deemed the date on which such notice is transmitted. The failure by either party to enforce any provision of this Agreement will not constitute a waiver of future enforcement of that or any other provision. Any waiver, modification or amendment of any provision of this Agreement will be effective only if in writing and signed by authorized representatives of both parties. If any provision of this Agreement is held to be unenforceable or invalid, that provision will be enforced to the maximum extent possible and the other provisions will remain in full force and effect. This Agreement (together with the Dealpath Customer Agreement) is the complete and exclusive understanding and agreement between the parties regarding its subject matter, and supersedes all proposals, understandings or communications between the parties, oral or written, regarding its subject matter.
